SECTION 6 ACCIDENTAL RELEASE MEASURES

During use in engines, contamination of oil with low levels of cancer-causing combustion products occurs. This product contains petroleum base oils which may be refined by various processes including severe solvent extraction, severe hydrocracking, or severe hydrotreating.
